SUBJECT : Periodical vehicles / equipment inspections

Dear Contractors,

Currently, the Rosebel H&S Department is assigned to conduct the Light Vehicle (LV) and Equipment inspections for contractors prior to accessing the Rosebel mine site, to confirm that these vehicles and equipment are in compliance with the company's standards.

As of August 1st 2022, all contractor LV and Equipment inspections will be carried out by **HEAVY CONSTRUCTION ACADEMY SURINAME N.V. (HCAS)** on behalf of RGM.

This safety inspection will apply to **all Light Vehicles, site support vehicles, busses, small trucks and highway trucks operating on the mine site and on public roads outside of the immediate boundaries of the operation.** Rosebel H&S Department will still conduct the inspections of equipment on tracks.

The vehicles will be classified in a similar manner as drivers and operators with regards to the operational application. The Inspections will be carried out at HCAS' facility in Paramaribo, following Rosebel standards and practices.

The inspections will be carried out with attached inspection checklist approved by RGM's H&S department. The checklist shall include, but not limited to, equipment systems with direct impact to the safe operation of the equipment i.e. brakes, steering, tires and safety accessories.

All vehicles and equipment, with exception of busses, will be inspected on a quarterly basis. Busses will be inspected on a monthly basis.

HCAS will certify the roadworthiness of the equipment by the placement of an operations and inspection declaration sticker that will be visible on the left-hand side of the vehicle windscreen. The stickers will be provided by RGM.

Contractors have until **October 31st** for making sure that inspections are conducted so that access to the mine site is guaranteed. Costs for inspections will be paid by the contractor.

The HCAS facilities that are available for inspection are:

- 1. PITBOX at the Eduard Brumastraat 190, Paramaribo.**
- 2. Calypsona Car Tech at Duisburglaan 7a, Paramaribo.**

Both are open on the following days:

- Monday till Friday from 08:00-16:00
- Saturday from 08:00-14:00

Please note that an appointment must be made for any vehicle / equipment inspection. This can be done by calling or sending a text/ WhatsApp message to HCAS on the number: **+5978669674**
